**Re: GOED Biennial Report to Legislature of Abatements from Taxation
Pursuant to NRS 231.0685**

The Governor's Office of Economic Development (GOED), pursuant to NRS 231.0685, submits this Biennial report to the Legislature. This report concerns abatements from taxation approved by the office pursuant to NRS 274.310, 274.320, 274.330, 360.750, 360.752, 360.753, 360.754. While state law requires this report cover the fiscal years which are three and six fiscal years immediately preceding the submission of the report, or fiscal years 2012 and 2015, respectively, GOED, in an effort to provide the legislature with additional information, is including fiscal year reports covering all 12 fiscal years from 2010 through 2022.

The attached reports address expanded criteria based on changes to state law enacted during the 2015 legislative session requested by the legislature including but not limited to:

1. The dollar amount of the abatement;
2. The location of the business for which the abatement was approved;
3. The value of infrastructure included as an incentive for the business; (none approved)
4. If applicable, the number of employees that the business for which the abatement was approved employs or will employ;
5. Whether the business for which the abatement was approved is a new business or an existing business;

6. The economic sector in which the business operates, the number of primary jobs related to the business, the average wage paid to employees of the business and the assessed values of personal property and real property of the business; and
7. Any information concerning whether the business for which the abatement was approved participates or has participated in a program of workforce development, as defined in NRS 231.146, implemented by the Executive Director (Faraday Future was approved for a workforce training program pursuant to NRS 231.146).

Introduction

This report goes through the years 2010 to 2022 and shows the Economic Development abatement programs administered by the Nevada Governor's Office of Economic Development.

Business abatements / incentives widely vary between each state and can comprise, but are not limited to, tax credits, tax abatements, grants, upfront cash payments, deal closing funds, and real property subsidies or gifts. Most states offer a mix of statutory and discretionary incentive programs. Nevada is relatively unique in that it offers an entirely statutory Tax Abatement program (NRS 360.750). Tax abatements are a reduction of taxes granted by a government entity to a company for a specific period of time to encourage economic development. These abatements are finite and performance based. The abatement program does not include any up-front cash funds or allocations from the state budget.

A company receiving a tax abatement enters into an agreement (a contract) with the state. Each contract allows a company to receive a predetermined reduction in its tax obligations (reduced tax payments) for a certain period of time. In return, the company receiving the abatement is obligated to invest a significant amount of capital into the economy, invest in people and training by creating new jobs and paying wages and benefits to those workers. Companies that receive abatements are regularly audited by the Department of Taxation to ensure they meet the abatement requirements. When the abatement period is over, businesses are obligated to continue paying the full amount of taxes.

2010 Economic Summary

The Great Recession began in 2007, bringing record-level economic hardship to the United States. Nevada was among the hardest-hit economies in the Nation. Over the course of the recession, Nevada lost 185,600 jobs. This new low in employment bottomed out in September 2010, with 1,112,400 jobs. Nevada also reached the highest level of unemployment in the State's history (only to be exceeded by the COVID disaster a decade later), with an unemployment rate of 13.9 percent by the end of 2010.

2011 Economic Summary

Although Nevada began a slow recovery from the Great Recession in 2011, the Silver State continued to lead the Nation in unemployment, foreclosure filings, and underwater mortgages. By the fourth quarter of 2011, 11.1 million Americans across the U.S. lived in homes in which the remaining balance on their mortgages was worth more than the full value of their houses.

Legislative Changes to Abatement Program (2011 Legislative Session)

The Nevada Governor's Office of Economic Development GOED was created during the 2011 session of the Nevada Legislature and is the result of a collaborative effort between the Nevada Legislature and the Governor's Office to restructure economic development in the state. GOED's role is to promote a robust, diversified, and prosperous economy in Nevada, stimulate business expansion and retention, encourage entrepreneurial enterprise, attract new businesses, and facilitate community development.

A.B. 449 (Chapter 507)

- Enacts various provisions relating to economic development. The bill creates an Advisory Council on Economic Development and a Board of Economic Development, and it prescribes the composition and duties of both entities. It also creates an Office of Economic Development, headed by an Executive Director, within the Office of the Governor, and eliminates the Commission on Economic Development. The bill includes a requirement that a State Plan for Economic Development is developed.
- Assembly Bill 449 also makes changes to tax abatements. It requires the recipients of certain abatements to repay the abated taxes if the recipients no longer meet the eligibility requirements.

By April 2012, Nevada's Trust Fund had fallen to nearly -\$800 million, as the length and depth of the recession put tremendous strain on the Unemployment Insurance (UI) system. While no year matched the outflows of 2009 during the Great Recession, from 2010 to 2012, UI benefit payments totaled \$1.84 billion. Despite the persistent volume of UI claims, by the end of 2012, 41,800 jobs came back to the economy from the recessionary trough.

2013 Economic Summary

In 2013, Nevada's economy began to see larger improvements from the recession. By mid-2013, the unemployment rate in the State fell below 10 percent for the first time since January 2009. By the end of 2013, 76,100 jobs were added back to the economy from the recessionary trough. Despite these positive movements in Nevada's economy, the State still faced hurdles in real estate, finance, and tourism. Nevada continued to struggle with underwater homes and foreclosures. As of the first quarter of 2013, Nevada still held the highest rate of underwater homeowners. About 45 percent of residents had mortgage debt that outweighed their homes' value.

2015 Economic Summary

By the end of 2015, Nevada was only 17,000 jobs short of the pre-recessionary high in employment. While statewide employment numbers had not yet recovered from the recession, the Las Vegas metropolitan area regained all the jobs lost during the recession by November 2015. Statewide, unemployment decreased to 6.3 percent by December – a vast improvement from the recessionary high of 13.9 percent.

Legislative Changes to Abatement Program (2015 Legislative Session)

Nevada's economy is demonstrating vast improvements. The abatement criteria is amended to as per SB 74 and the Data Center and Aviation abatements are introduced for the purposes of Nevada's competitiveness with surrounding states and the desire to grow these industries in Nevada.

S.B. 74 (Chapter 227)

- Changes requirements applicable to businesses applying for a partial abatement of certain taxes. To be eligible for a partial abatement, a business must offer primary jobs and meet certain employment requirements within a period of two years. The bill also limits the availability and number of abatements based on the rate of unemployment in the county and the average hourly wage paid by the business to its new employees.

S.B. 170 (Chapter 498)

- Authorizes a partial abatement of personal property taxes and local sales and use taxes to a qualified data center that locates or expands in this State and any co-located businesses within a qualified data center.

A.B. 161

- Assembly Bill 161 authorizes a partial abatement of taxes for up to 20 years for certain qualified new and existing businesses that own, operate, manufacture, service, maintain, test, repair, overhaul, or assemble an aircraft or any component of an aircraft.

In early 2017, Reno-Sparks finally regained all the jobs it lost and exceeded its pre-recessionary peak total. Legislative Changes to Abatement Program (2017 Legislative Session)

Due to the Economic improvements seen over the recent 18 months, the abatement wage criteria were amended as follows:

If the unemployment rate of a county is under 7%:

- Companies must pay 100% of the Statewide average wage, as set by DETR on July 1 of each fiscal year, to qualify for standard abatements.
- Companies paying 85% to 99% of the lesser of the Statewide average wage may be eligible for reduced abatements.
- Companies paying less than 85% of the statewide average wage would no longer be eligible for abatements.

In 2018, Nevada firmly lead the country in private sector job growth, attaining more than 1.4 million jobs by December. Initial Unemployment Insurance claims averaged 2,390 claims per week in 2018. 2019 Economic Summary

Nevada's economy continued to boom in 2019, reaching nearly 1.45 million jobs and hitting 108 months of consecutive year-over-year growth by the end of the year. Nevada's unemployment rate was also at an all-time low in December 2019, at 3.6 percent. During the recession, Nevada concentrated on strengthening its economy through economic diversification. As a result, the share of Tourism employment shrank significantly during the recovery (-4.7 percentage points from 2011 to 2019), while industries such as Health Care, Logistics and Operations, Information Technology, and Manufacturing realized gains in their employment share.

Legislative Changes to Abatement Program (2019 Legislative Session)

Nevada's overall unemployment rate is at an all-time low in January 2020. The 2019 Legislative Session saw the abatement criteria amended as follows:

AB400:

- Reduces GOED's ability to abate the Local School Support Tax (new business can abate, expanding business cannot).
- Reduces the number of instances a new or existing company can receive tax abatements; – New businesses can receive one incentive package for moving to a Nevada county (includes the Local School Support Tax) and can apply for one round of expansion abatements (cannot include the LSST); – Existing companies may only apply for one expansion incentive package as long as they have never received abatements (cannot include the LSST).
- Companies receiving the \$3.5 billion or \$1 billion abatement packages can no longer receive an abatement on the LSST portion of the Sales and Use Tax.
- Reduces aviation tax abatement from 20 years to 10 years; and
- Requires the GOED Board to approve aviation and data center abatements by a two-thirds vote

2020 Economic Summary

The COVID-19 pandemic caused the biggest blow to the US economy since the Great Depression. Nevada and Hawaii saw the largest decline in real gross domestic product, down 49.6 and 44.7 percent, respectively. Both economies are heavily reliant on tourism. The national average was down 29.9 percent. At the peak of unemployment in April 2020, Nevada's unemployment rate was 28.5 percent — the highest unemployment rate recorded in any state ever. In the Las Vegas area, the unemployment rate was 31.1 percent. In the Reno area, it was 18.2 percent. Statewide initial weekly unemployment insurance claims breached more than 11,000 during the peak of the recession. Over 2020, regular UI benefit payments totaled \$2.5 billion.

2021 Economic Summary

Throughout 2021, Nevada's economy was recovering from the pandemic-induced recession. The State recovered 130,100 jobs during the year, and the unemployment rate decreased to 5.3 percent by December. Las Vegas was still down 27,300 jobs from the pre-pandemic peak by the end of the year, the bulk of which belonged to the Leisure and Hospitality Sector. Meanwhile, Reno's economy essentially recovered, down only 100 jobs from February 2020.

Legislative Changes to Abatement Program (2021 Legislative Session)

The economy in Nevada continues to recover from the severe impacts of the pandemic. The 2021 Legislative Session saw revisions to the abatement program as follows:

A.B. 66

- Revises provisions relating to the abatement of certain taxes. This bill prohibits companies from receiving an abatement past one year after entering into an agreement. If the applicant fails to enter into an agreement within one year after the application is received, the applicant is required to submit a new application.

A.B. 69

- The Director of the Department of Business and Industry is added as a nonvoting member to the Board of Economic Development.

2022 Economic Summary

In June 2022, Nevada fully regained all the jobs lost during the COVID-19 disaster. As of October, the Silver State is at a new all-time high of 1,471,800 jobs. Although the number of jobs fully recovered, Nevada's economic composition permanently changed from the recession. Nevada's hardest-hit sector, Leisure and Hospitality, remains nearly 20,000 jobs below pre-pandemic numbers. Meanwhile, most other private sectors have realized significant employment gains, Manufacturing being one of the largest increases, adding roughly 8,000 jobs.

While the economy is relatively strong at the end of 2022, there is speculation of a slight recession soon due to heightened inflation rates, softening job openings and hires, and slowed growth in the gross domestic product, among other concerns.

\$3.5 billion abatement is introduced in a special session.

S.B. 1 (Chapter 4)

- Authorizes an full abatement for 10 years on personal property taxes and modified business taxes, as well as a partial abatement of the local sales and use taxes for 20 years to a qualified business with a capital investment of at least \$3.5 billion in this State.

2015

Data Center and Aviation abatements are introduced for the purposes of Nevada's competitiveness with surrounding states and the desire to grow these industries in Nevada. \$1 billion abatement is introduced in a special session.

S.B. 170 (Chapter 498)

- Authorizes a partial abatement of personal property taxes and local sales and use taxes to a qualified data center that locates or expands in this State and any co-located businesses within a qualified data center.

A.B. 161

- Assembly Bill 161 authorizes a partial abatement of taxes for up to 20 years for certain qualified new and existing businesses that own, operate, manufacture, service, maintain, test, repair, overhaul, or assemble an aircraft or any component of an aircraft.

Audit Results for Approved Tax Abatements

Fiscal Years 2010 through 2022

Standard, Aviation, and Data Center abatements are audited at the two-year and the five-year mark from the date of a company's signed contract. To be deemed compliant, companies must meet the statewide average wage at the time of application for abatements and meet the statutory requirement for either employment or capital investment. It should be noted that statutory requirements have shifted over legislative sessions. Current requirements can be found here: https://goed.nv.gov/wp-content/uploads/2022/12/2022_GOED_Incentive_Guide.pdf.

To provide the most astute assessment, the following section compares the audited company data to the projections for wages, employment, and capital investment each company provided at the time of its contract, rather than the statutory requirements. These estimates provide each company's best estimate of the economic benefits they will bring to Nevada once they have been established for two years. These projections often exceed the minimum requirements to receive abatements in Nevada. A company does not need to meet its projections to be deemed compliant so long as they meet the statutory requirements.

The \$1 billion and \$3.5 billion abatements are audited by a third party. These audits are available in separate reports on the Nevada Governor's Office of Economic Development's website.
