

## NOTIFICATION OF FUNDING OPPORTUNITY

**PURPOSE OF MEETING:** The Governor's Office of Economic Development/ Community Development Block Grant program (CDBG) has been awarded \$1,620,125 for the Recovery Housing Program (RHP) a pilot program to support individuals in recovery from a substance use disorder become stably housed. U.S. Department of Urban Development (HUD) to support individuals in recovery onto a path to self-sufficiency. Funds appropriated or made available for the Recovery Housing Program (RHP) will be treated as Community Development Block Grant (CDBG) funds and will be governed by the CDBG regulations. This pilot program authorizes assistance to grantees (states) to provide stable, temporary housing to individuals in recovery from a substance use disorder.

CDBG has determined to use both rounds of funding for the following eligible activities:

- Public Facility Improvements
- Acquisition of Real Property
- Rehabilitation and Reconstruction
- Disposition of Real Property Acquisition
- Clearance and Demolition
- Relocation and
- New Construction

The RHP application process will open November 1<sup>st</sup>, 2022 in ZoomGrants; applications will be accepted until December 31, 2022.
