JOBS ANNOUNCED BY ASSISTED COMPANIES

In the fourth quarter, 15 companies added 459 jobs to Nevada's economy. This brings the annual total to 3,775 additional jobs brought on-line by 87 companies. Once these companies are fully staffed, the build-out job estimate is 7,777.

For the year, 38 percent of the assisted companies were manufacturers followed by logistics and operations (23 percent), and information technology (17 percent). The remaining 22 percent were evenly split between the aerospace, healthcare, tourism, mining, natural resource, and finance sectors.


WAGES PAID BY ASSISTED COMPANIES


The average hourly wage paid by assisted companies in the fourth quarter was \$33.15. This reflects a \$4.08 hourly increase from the previous quarter, and \$8.08 from a year ago. Worker pay for companies receiving incentives was \$35.79 per hour as compared to non-incentivized company pay of \$23.59 an hour. The average hourly wage for all assisted companies in 2018 was \$29.44.

ASSISTED COMPANY INVESTMENT

Capital investment by assisted companies came in at \$33.3 million in the fourth quarter. This reflects a \$250.5 million, or 88.3 percent decline from the third quarter. For the year, total capital investment was \$714.5 million, an 82.3 percent increase over the \$392.0 million reported last year.



CONTRACT AND ACTUAL JOBS BY NEW INCENTIVIZED COMPANIES




As new incentivized companies add staff, the number of actual jobs has exceeded those that were contracted.

In 2018 there were two Data Centers and five Aviation companies that received abatements. Total capital investment by these seven companies stands at \$7.2 billion.


RECRUITMENT ACTIVITY: 2017 Q4 -2018 Q4



There were 15 wins in the fourth quarter of 2018. This represents a 44.4 percent decrease from the third quarter, but the same amount as reported last year.


Activity in the earlier stages of the recruitment pipeline during the fourth quarter was mostly positive. When compared to the third quarter, Leads were up by 155.8 percent and Prospects by 34.1 percent. When compared to last year, Leads were up by 1.9 percent, but Prospects were down by 33.7 percent.

SIZE OF COMPANY ASSISTED



Nevada's official definition of a small business are those which employ fewer than 150 employees and 92.2 percent of companies assisted by economic development over the past six years fit that definition. Less than 1 percent employ 500 or more workers.

NEW AND EXISTING INCENTIVIZED COMPANIES



Of the assisted companies receiving incentives since 2012, 58 percent are new companies who have relocated to the state and 42 percent are existing Nevada businesses expanding their operations.




GLOBAL RECRUITING: Q4 2018

INTERNATIONAL TRADE

- » Last year Nevada Global, a statewide international recruitment platform with multiple Nevada partners, was launched. At that time negotiations with Poland began and resulted in the first acceleration program focusing on high growth, foreign companies looking for soft-landing opportunities in the U.S.
 - » To date, 35 competitively selected international companies from Central Europe, Eastern Europe, and Italy participated in structured bootcamp programs in both Northern and Southern Nevada.

WINS

- » Five Nevada Global companies are now members of Nevada Chambers of Commerce; two have active projects with UNLV and WNC, and three are moving their international headquarters to Nevada.
- » Another acceleration program between GOED and the Mazovian Voivodship Provincial Office in Poland was prepared in December, 2018. The first innovative European scaleups will be selected in June and will take part in a Nevada immersion program beginning in November of this year.
- » Through Nevada Global, the International Division has also attracted prospective investors from the Czech Republic including an innovative battery producer.
- » During the period, the International Division successfully promoted joint drone testing between the Nevada Institute of Autonomous Systems (NIAS), NASA, and the Polish Institute of Aviation. The Polish Institute of Aviation has since become a major foreign partner with NIAS.
- » Beginning last June, GOED took an active role in developing a grant application between the UNR College of Business and the Warsaw School of Economics, which was finalized in October. This grant for \$207,000 will support over 30 faculty and startup exchanges, as well as joint economic development symposiums. The first symposium was held in Reno last December.
- » The International Division also administers the State Trade Expansion Program (STEP) Grant in cooperation with the U.S. Small Business Administration. The STEP Grant helps Nevada Eligible Small Businesses with financial assistance to expand into international markets. Sixteen companies were awarded \$98,520 in grant funding over the third and fourth quarter with the most recent being announced in January.




- » The Nevada Procurement Technical Assistance Center (PTAC) reported the highest number of contracts and the second highest contract amount in the first half of this fiscal year than for the same period in all previous years on record. The number of clients slipped slightly, but is still well above historical counts.
- » Consistent growth in PTAC metrics persist as the division continues its one-on-one counseling sessions as clients pursue local, state, and federal government-related contracts in Nevada and across the country. Counseling, in part, includes help with solicitation document review, draft proposal review, and contract administration guidance. The PTAC also provides free outreach events such as small business matchmakers.

- » The current number of Emerging Small Businesses (ESB's) that have been certified has expanded by 19.9 percent since the end of last year to a total of 1,366.
- » Local government agencies have until the end of March to report solicitation and contract metrics. Soon after those are received, the complete annual ESB activity report of both state and local agencies will be sent to the Governor's Office, the Legislative Council Bureau, and posted to the GOED website.

RURAL GRANT PROGRESS

- » During the fourth quarter, \$755,971 was paid to three rural counties and four rural cities.
- » CDBG staff closed four grants in three rural communities representing \$448,160 in CDBG funds. These projects contributed an additional \$269,013 in leveraged funds.
- » Closed grants in the quarter assisted 6,865 Nevadans; 6,467 (94.2 percent) were considered Low to Moderate Income.
- There are currently 32 open grants: 3 from 2016, 15 from 2017, and 14 from the 2018 program funds. Federal budgets were not approved until May of 2018, delaying the allocation process.

URBAN COMMUNITY DEVELOPMENT BLOCK GRANTS


- » Carson City reverted to the state's CDBG program in 2017 receiving \$459,890 in HUD allocation to fund six projects. Carson City's focus is urban with different priorities than GOED's existing rural programs.
- » Future urban project recommendations for funding will be reviewed to award grants with greater economic development impact.

NEVADA JOBS AND UNEMPLOYMENT

The number of workers in Nevada's economy continues to set record levels and currently stands at 1,416,500. This reflects a gain of 304,100 jobs since the recessionary low and 119,200 above the pre-recession high. Annual job growth is currently 3.9 percent and more than double the current U.S. growth rate of 1.9 percent.

The unemployment rate currently stands at 4.4 percent; a 0.4 percentage point improvement from this time last year and 9.3 points below the recessionary high of 13.7 percent. The prerecession unemployment low was 3.9 percent.

AEROSPACE AND DEFENSE



With the addition of 280 jobs, there are currently 15,400 workers employed in Nevada's Aerospace and Defense sector. Average annual earnings were essentially flat, slipping by \$380 to \$86,300 per year. When compared to last year, there has been a 9.2 percent increase in jobs and a 1.3 percent increase in earnings.

BUSINESS INFORMATION TECHNOLOGY



The number of jobs in Nevada's Business Information Technology sector expanded by 2,580 in the current quarter to a total of 71,100 workers in the sector. Average annual earnings were essentially unchanged with only a slight improvement of \$250 per year and now stand at \$48,700. For the year, job counts have improved by 12.0 percent and earnings by 1.9 percent.


Jobs — Average Earnings per Job

HEALTH AND MEDICAL



When compared to last quarter, an additional 1,590 jobs were added to Nevada's Health and Medical sector for a total of 118,600 workers employed. The sector also realized a \$400 per year bump in annual earnings which now stands at \$57,200. When compared to last year, job counts in Nevada's healthcare sector have expanded by 7.2 percent and earnings by 1.6 percent.

MANUFACTURING AND LOGISTICS



There was a drop of \$460 in average annual earnings in Nevada's Manufacturing and Logistics sector which now stands at \$58,500. This decline was driven largely by the addition of a large number of entry level positions. In total, job counts improved by 3,970 workers bringing total employment in the sector to 140,800. For the year, jobs have grown by 15.1 percent with an earnings decline of 1.0 percent.

NATURAL RESOURCE TECHNOLOGIES



There are currently 64,300 workers in Nevada's Natural Resource Technologies sector with the addition of 2,100 jobs in the current quarter. Average annual earnings have been unchanged and currently stand at \$65,700. When compared to last year, job counts have improved by 22.6 percent while earnings have slipped by 1.0 percent.

MANUFACTURING



Growth has been strong in Nevada's Manufacturing sector with the addition of 2,300 workers in the fourth quarter. Currently there are 53,800 workers employed in the sector making, on average, \$56,300 per year. Since last year, job counts have grown by 19.9 percent and average annual earnings by 1.0 percent.

MINING

Job counts in Nevada's Mining sector bumped up slightly in the fourth quarter with the addition of 120 workers for a total of 14,600 employed in the industry. Average annual earnings also improved by \$600 and now stands at \$95,800. When compared to last year, job counts have improved by 4.9 percent and earnings by 0.3 percent.



TOURISM, GAMING, AND ENTERTAINMENT

Job counts in Nevada's Tourism, Gaming, and Entertainment sector grew by 2,600 positions in the current quarter bringing total employment in Nevada's largest sector to 431,200. Annual earnings were essentially flat with a slight increase of \$118 to a total of \$33,476. For the year, jobs have grown by 3.2 percent with an earnings decline of 2.1 percent.
