## Australia Export Mission (Brisbane and Sydney)

### General Information

#### Hotel

Hotel arrangements will be made by the responsibility of the company to attend all components of the itinerary below. Hotel costs are the responsibility of the company, and they will not be reimbursed by the Export Grant Program. Please see the application guidelines online for more information on eligible costs for the program. The recommended hotel for this Export Mission is Courtyard by Marriott in both Sydney and Brisbane. The average cost/night is about \$110 USD plus taxes. Please see the links above to access the booking page and location address.

#### Transportation

Flights will be arranged and purchased by the company to attend all components of the itinerary above. Flights must be economy class or lower. Flights must arrive within two days before the start of the program, and they must depart within two days of the end of the program. These flights are eligible for reimbursement following the export mission. Other transportation costs are the responsibility of the company.

#### Other

Nevada GOED will have a representative on the ground should you have any questions in-country or run into any issues with your meeting schedule. Both the federal representatives in Australia and the Nevada GOED staff are looking to help you succeed in your new target market through this opportunity.

### Deadlines and Next Steps

The deadline to apply for this mission is May 13 2024. There are only ten spots available for this mission. Companies must have an export/outreach plan elaborated in their application. Should the spots for this mission be succeeded by the number of applicants, a competitive review process will be engaged.

To fully apply for this mission, please follow these next steps:

1. Apply for the trade mission through the export grant application, found in the Apply Now button on the information flyer or the GOED Export Grant Program website: <https://goed.nv.gov/nevada-export-grants/>.
2. Complete the "Export Interest Questionnaire" that will supplement your application and provide insight for the meetings you are looking to secure in Australia. This document will be sent to the once the application is submitted to GOED, and it will be immediately required to be submitted if accepted on the Trade Mission.
3. Await acceptance to the mission, which will come on a rolling basis within two weeks of application submission. Once confirmed as an attendee on the mission via the contract, eligible purchases may be made based on the information provided by GOED.
