## NOTICE OF PUBLIC HEARING FOR THE STATE OF NEVADA'S 2025 ANNUAL ACTION PLAN ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING AND 2025-2029 CONSOLIDATED PLAN

In accordance with 24 CFR 91.105, the State of Nevada has made its draft U.S. Department of Housing and Urban Development Analysis of Impediments to Fair Housing (AI), 2025-2029 Consolidated Plan (Con Plan), and 2025 Action Plan available for public review and comment. The AI identifies impediments to fair housing choice within the State and outlines the actions to be taken to overcome the effects of any impediments identified. The Con Plan describes how the State will use funding from the U.S. Department of Housing and Urban Development (HUD) in the 2025-2029 program years. For the 2025 program year, the State will receive \$10,096,035.46 in funding from HUD for the Community Development Block Grant (\$2,910,779), HOME (\$3,014,372.26), Housing Trust Fund (\$3,134,373.20), Emergency Solutions Grant (\$492,047) and HOPWA (\$544,464) programs. The overall goal of these programs is to develop viable urban communities by providing decent housing, suitable living environments, and expanding economic opportunities principally for low – and moderate-income persons. It is estimated that 4,300 beneficiaries will benefit from these programs.

Copies of the plan are available for public review and comment beginning June 9, 2025 in the Governor's Office of Economic Development (GOED), the Nevada Housing Division, all City and County Administration offices (except Reno, Sparks, and city and county offices within Clark County), and at <a href="www.goed.nv.gov">www.goed.nv.gov</a>. To be incorporated into the State's plan to HUD, all comments must be submitted to the Nevada Governor's Office of Economic Development, Attention Jessica Sanders, 808 West Nye Lane, Carson City, NV 89703, or e-mailed to <a href="mailed-to-jsanders@goed.nv.gov">jsanders@goed.nv.gov</a>, no later than July 9, 2025.
